Terms and Conditions:

1. Arrangements for gear rental (both pick up and return) can be made through the SA Office, Room 119 Kelsey Campus or by calling 659-4421.
2. Renters are responsible for returning the gear to the SA Office by the date indicated on this Rental Agreement. Failure to comply will result in late fees being charged.
3. Renters will be required to pay for the rental in full prior to receiving equipment. A credit card number will be required as deposit.
4. Renter must complete the Kelsey Campus Recreation Release, Waiver and Assumption of Risk Form.
5. The Customer hereby acknowledges that the Equipment has been inspected, is in good operating condition, is fit for its intended purpose and is in all respects as represented.
6. The Customer shall have no right, title or interest in the Equipment, which shall at all times remain with Kelsey Campus Recreation. In the event the Customer fails to return the equipment on the Return Date or fails to abide by any other term of this Agreement, Kelsey Campus Recreation may repossess the Equipment without notice to the Customer and Kelsey Campus Recreation is released from all claims arising there from.
7. The Customer shall use the Equipment only for its intended purpose and operate the Equipment carefully and in the compliance with manufacturer's recommendations and applicable laws and regulations, by competent duly qualified personnel. The Customer shall at his/her own cost and expenses keep the equipment in good repair, condition, and in working order.
8. The Customer agrees not to sell, assign, sublet, pledge, hypothecate, or otherwise encumber or suffer a lien upon or against an interest in this Agreement of the Equipment.
9. The Customer shall return the Equipment to Kelsey Campus Recreation on the Return Date at his/her own risk and expense, in the same condition as when delivered. Kelsey Campus Recreation shall inspect the Equipment on return and shall at its sole and exclusive discretion apply all of part of the cost of remedying any uncleanliness, defect, or damage to the Equipment on return to Kelsey Campus Recreation. These charges will be applied to the credit card named above. The Customer agrees to indemnify to Kelsey Campus Recreation for any damages, costs and expenses resulting from Equipment being returned after the Return Date.
10. The Equipment shall be used at the risk of the Customer. Kelsey Campus Recreation expressly disclaims any duty as an insurer of the Equipment herein and the Customer shall pay for all costs of repair and parts of replacement of the Equipment deemed necessary, by specifically, but not limited to, loss or damage through accident, abuse, misuse, theft, fire, water, casualty, natural force or any other negligent act.
11. The Customer freely and voluntarily assumes all of the risks and hazards associated with use of the Equipment and hereby release Kelsey Campus Recreation, its Directors, Employees, Representatives, and Agents from all liability and does hereby waive as against Kelsey Campus Recreation its Directors, Employees, Representatives, and Agents from all resources, claims, causes of action of any kind whatsoever in respect of all personal injuries or property losses which the Customer may suffer arising out of or in connection with use of the Equipment, notwithstanding that such injuries or losses have been caused solely or partly by negligence of Kelsey Campus Recreation or any of its Officers, Directors, Employees, Volunteers, Agents and Representatives.
